

Dreambox Inc. respects your privacy. As we collect, maintain and store your personal information when you visit the Website (www.smartlearnerindia.com), we consider it our responsibility to maintain the privacy and confidentiality of the personal information we collect.

We have developed this Privacy Policy in order to let you understand how and why we collect, use, manage, disclose, transfer, and store your personal data.

The Dreambox Privacy Policy

This Privacy Policy provides essential details related to your personal data relationship with DreamBox Inc. (hereinafter referred to as “DreamBox” “we” “our” or “us”). By using the www.smartlearnerindia.com (hereinafter referred to as “Website”), you are accepting the practices described in this policy. If you do not agree to this privacy policy, please DO NOT USE the Website or any feature or service provided through the Website.

Changes in the Privacy Policy

DreamBox provides IT service “**Smart Learner India**” (hereinafter referred as SLI) which are subject to change from time to time. The change impacts what and how the data is collected, which is also implicated in the Privacy Policy. DreamBox reserves the right, in its sole discretion, to amend the provisions in Privacy Policy. Any amendment in the policy will be immediately effective post the changes published on the Website, indicated by the “**Effective Date**”.

You are solely responsible to review the privacy policy periodically.

The Data We Collect from You

This section describes the information we collect and manage from you for better understanding of your preferences and for our own marketing. We categorize all the data that we collect into three sections:

- Personally, identifiable information that you voluntarily submit to us, such as name, email address, company name, designation, mobile number, telephone number, postal address, each classified as “personal information”.
- Navigational information that refers to information about your Internet connection, device used for visiting our website, and usage details such as IP address, browser type, referral source, geographical location, referral source, duration of time spent on website, and pages viewed. IP address is tracked primarily to identify malicious activities and black list any such threatening sites or sources.
- Financial and payment information, including credit card numbers and billing information related to orders placed through any platform or the Website.

How Do We Collect the Data?

We collect the information when you navigate through the Website or voluntarily submit your information or through any other interactions with DreamBox. The information collected on or through the Website may include:

- Details you fill in the forms on the Website;
- Information provided to you in response to our marketing communication, employment opportunities on the Website or through other platforms;
- Any Website page that you visit, including your search queries on the Website, images you viewed, or website content viewed or downloaded from our Website.
- Information you share with us on publicly accessible platforms such as blogs, social media sites such as Facebook or Twitter, and community forums.

How we use collected information

SLI may collect and use Users personal information for the following purposes:

- **To improve visitor service:**
Information you provide helps us respond to your visitor service requests and support needs more efficiently.
- **To improve our Site:**
We may use feedback you provide to improve our services.
- **To send periodic emails:**
We may use the email address to send User information and updates pertaining to their order. It may also be used to respond to their inquiries, questions, and/or other requests. If User decides to opt-in to our mailing list, they will receive emails that may include company news, updates, related product or service information, etc. If at any time the User would like to unsubscribe from receiving future emails, we include detailed unsubscribe instructions at the bottom of each email.

How we protect your information

We adopt appropriate data collection, storage and processing practices and security measures to protect against unauthorized access, alteration, disclosure or destruction of your personal information, username, password, transaction information and data stored on Website.

Sharing your personal information

We share information as discussed below, but we won't sell it to other third parties. We share your personal data with your consent or to complete any transaction or provide any product you have requested or authorised. We also share data with DreamBox controlled affiliates and subsidiaries; with vendors working on our behalf; when required by law or to respond to legal process; to protect our visitors; to protect lives; to maintain the security of our products; and to protect the rights and property of visitors.

Affiliates and Vendors working for and with DreamBox.

Affiliates such as user support provider, our payment gateway processors, email processors and the accountant. The use of this DreamBox website is done at your own discretion and risk and with agreement that you will be solely responsible for any damage to your computer system or loss of data that results from such activities. You are solely responsible for adequate protection and backup of the data and equipment used, and we will not be liable for any damages that you may suffer and we shall not be liable for their misconduct regarding your information.

Law & Order and the Public Interest.

We may disclose your information to third parties if we determine that such disclosure is reasonably necessary to:

- (a) comply with any applicable law, regulation, legal process, or appropriate government request;
- (b) prevent fraud;
- (c) protect DreamBox website's rights, property, safety, or interest; or
- (d) perform a task carried out in the public interest.

Business Partners.

We collaborate with advertising partners, marketing and communication agencies. We do this for (interest based) advertising, branding and reaching out to you.

Integrated services.

If you decide to integrate our Services with another service (your social media account) we will connect that service with ours. In order to provide such service, we will need to share some of your personal information with that service. The terms and privacy & cookie statement of these third parties applies, at least for their part of the connection.

We will retain, access, transfer, disclose, and preserve personal data, including your content (files in folders), when we have a good faith belief that doing so is necessary to do any of the following:

- Comply with applicable law or respond to valid legal process, including from law enforcement or other government agencies.
- Protect our visitors, for example, to prevent spam or attempts to defraud users of our products, or to help prevent the loss of life or serious injury of anyone.
- Operate and maintain the security of our products, including to prevent or stop an attack on our computer systems or networks.
- Protect the rights or property of DreamBox website, including enforcing the terms governing the use of the services—however, if we receive information indicating that someone is using our services to traffic in stolen intellectual or physical property of DreamBox website, the Admin of DreamBox website will inspect a visitor's private content and if needed we may refer the matter to law enforcement too.
